I assume all risks associated with my use of the Cyclo-Café and will not bring any action against Cyclo-Café, its operators, its manufacture, its successors and/or assigns, for personal injury, property loss, or property damage, including any action for negligence, breach of warranty, products liability or strict liability.

The Cyclo-Café is of proprietary manufacture and design. I agree not to infringe the proprietary rights of Cyclo-Café's manufacture and designer. I further agree to release, indemnify and hold harmless the operators, owners and manufacturers of the Cyclo-Café, from any liability against any and all claims, including damages or demands of third parties as a result of my use of the Cyclo-Café.

1. All cyclists aboard must be majority, 18 years of age or accompanied by a parent/ legal guardian.
2. All cyclists are responsible for his/her own behavior and good conduct, including strict adherence to any public/ safety laws throughout the tour.
3. The Cyclo-Café Driver/ Pilot will be provided on all tours. He/ She is responsible for organization, enforcement of rules on the Cyclo-Café, and his/her decisions are final.
4. Inappropriate behavior before, during and after tours will result in the offending person(s) being asked to disembark the Cyclo-Café. These include but, not limited to:

- Violation of public/ safety laws • Foul Language or Gestures • Excessive noise •
- Disturbances to Cyclo-Café Riders • Disturbances to the General Public •

5. Severe transgressions of the above will result in the Pilot ending the tour immediately, and causing a Late/Damage Fee of €200, to be charged to the Renter's credit card.

6. All public/ safety laws and rules regarding alcohol apply to all persons/cyclists before, during and after Cyclo-Café tours. I assume responsibility for these laws at my own risk.

7. All cyclists acknowledge that all aboard, at the start of a tour, are required to conduct the bicycle throughout the duration of the tour. A €100 "Abandonment" fee will be charged to tour riders not returning to the starting point.
